President's Message

As newly elected U.R.A. officers and board members, we have three major responsibilities:

- finding ways to promote growth in the sport of racquetball in Utah
- exposing more non-U.R.A. members to sanctioned events
- enhancing our formats to meet the desires of existing U.R.A. members.

To administer the organization, we must consider the AARA requirements and then must juggle our personal and work schedules. This is quite a task. That's why I'm asking for your support. What I'm really asking for is for each of you to support your own ideas. I'll explain.

For the past couple of years, you, the U.R.A. membership, have been asking for more weekend tournaments. Last year the Sports Mall held a very successful weekend tournament with over 100 entrants. At our annual meeting in June 1996, a discussion took place and you, the U.R.A. membership, decided you wanted four or five weekend tournaments a year. These tournaments should be spread out so that there is never more than one weekend tournament per month. The tournaments should also be located at different clubs around the valley, which should promote traveling to these tournaments. During this discussion, you determined that we should get more out-of-town. would not require taking a week off work to play in a tournament.

Juniors Team Racquetball A Hit!

Racquetball excitement continues through the summer as junior players representing eight clubs from Ogden to South Jordan compete each week. Each club has a team of up to 10 players ranging from 8 to 18 years old. The season started with a Rules Clinic given by John Yorkey on June 11. The juniors learned the rules and how to referee a match. Each week two clubs meet and compete in a team format. All matches are refereed by the juniors. A skills clinic was held on July 16 at the Redwood Center. Adam Anderson demonstrated what it takes to be State Champion by directing the juniors as they competed in various skills such as kill and passing shots. Awards are given to the team who accumulates the most points by summer's end. Referee testing and certification is done on August 14. The season climaxes with the State Juniors Championships held at the Redwood Center on August 15-17. This tournament culminates with an awards ceremony and Barbecue for all participating teams on August 17.

Ruth McGovern of the Redwood Center has done an excellent job (as usual) to organize this League. The clubs have donated court time and the support of the parents has been great. As of press time, the season is 3/4 over and all the kids are looking forward to the tourna y' in August.

As a coach, it's very rewarding to watch our juniors grow and improve with each week. I recommend that you watch these kids play. The growth of our sport is dependent on a strong juniors program. This was evident last year with the strong improvement shown by the younger players during the regular tournament season. Are you introducing your kids to racquetball? If not, you're both missing out.

1995–1996 saw the first year of the new traveling league. Six clubs participated, with each team playing one another once at their home club and once at the opposing team's club. The teams were made up of men, women, and even a few juniors. Each tournament consisted of four men's singles matches, two women's singles matches, and one men's, women's, and mixed doubles match. Each match was played in the regular tournament format. The player who won their match earned a point for their team. Points were accumulated during the season and at season's end the points determined the seeding for a tournament that began in May.

First place went to the team from Sports Mall. Coach Tony Glavas commented that "the team was great and had a lot of support, but the Sports Mall women were the ones who came through for the team when it counted." Second place went to the Redwood Center's team, Deseret Gym took third, and the Bountiful Recreation Center was fourth. The other participating teams were Alta Canyon and Towne & Country. The season ended with a banquet at the Redwood Center where a plaque was awarded to the Sports Mall and Redwood Center for taking first and second place, respectively.

The traveling league gave everyone the opportunity to play for the pride of their home clubs. The participants enjoyed meeting other players and playing at different facilities. Ruth McGovern led the effort in organizing the teams and setting the schedule for the season. The U.R.A. extends their thanks to Ruth for her excellent work. We are looking forward to an even better 1996-1997 season with additional teams and players. An organizing meeting for the clubs was held on Tuesday, August 6th, at the Redwood Center.
